Bidding is open to all interest bidders.

The foreign bidders are entitled to bid only in a joint venture with a Pakistani Firm in accordance with the relevant provisions of PEC by-laws.

 - ✓ The Contractor / Firm should be registered from Sindh Revenue Board.
