# LEGAL SERVICES

a) Name and Address

The **Sindh Building Control Authority (SBCA)** is an Authority constituted under Sindh Building Control Ordinance, 1979, headquartered at Civic Centre, Annexe, University Roard, Gulshan-e-Igbal, Karachi.

b) Description of Service

The SBCA intends to engage professional services of reputable law firm / Advocates registered with the Sindh Bar Council and FBR, in accordance with applicable laws, for researching and preparing legislative proposals for amendments in the said SBCO-1979, Building & Town Planning Regulations-2002 (As amended upto date), its relevant rules and regulations to be prepared within three (3) months from the date of contract.

The said law firm / Advocates shall enjoy at least 10 years good standing before a High Court and experience in preparing legislative proposals and drafting, specifically in matters pertaining to Building Control laws and Town Planning Regulations 2002 (as amended up to date) and other relevant rules.

The Interested law firms / Advocates will submit their proposals detailing their expertise and proposed fee as bid in a sealed envelope addressed to the undersigned and will clearly mention (Bids for legal 'Services) in bold and legible letters on respective envelope to avoid any confusion.

Sindh Building Control Authority reserves the right to reject any or all bids at any time, however, reasons for rejection or annulling bid process will be communicated to the concerned bidder(s) in accordance with the Sindh Public Procurement Rules.






