## INSTRUCTION TO BIDDERS

- 1) Bids shall remain open for 60 days from the date of opening. A bid valid for a shorter period shall be rejected as being non-responsive.
- 2) The bidders shall quote their prices inclusive of all duties/taxes/Octori transportation etc, and all other expenses on free delivery to Consignee's end.
- 3) The bid prepared by the Bidder shall comprise the following documents.
  - a) The original tender purchase receipt.
  - b) Bidder shall purchase separate tender document and furnish purchase receipts for alternate offer, in case they want to submit alternate offer. Any item's bid with alternate offers without separate purchase receipt (Original) is supposed to be rejected.
  - c) The Bidder shall furnish a bid security @2% of the quoted value in the form of pay order, bank draft
  - d) Bid form & Price Schedules duly completed by the bidder.
  - e) Sole Agent Certificate/Authority letter from the manufacturer must be provided by the bidder.
  - f) The Service manual with circuit diagram will be provided (for equipment).
  - g) The bidder shall furnish copy of valid Professional Tax (Excise & Taxation) Income Tax Certificate/GST Registration Certificate (where applicable).
  - h) Tenderers shall submit guarantee letter that the supplied Machinery/Equipment is the original/brand new product/latest model, non of the part is replaced, old or refurbished.
- 4) The prices quoted by the Bidder shall be fixed during the performance of the contract and not submit to variation on any account. A bid submitted with an adjustable price or condition will be treated as non-responsive and rejected.
- 5) The Bidder shall prepare bid comprise one single envelop containing separately FINANCIAL PROPOSAL and TECHNICAL PROPOSAL in original. The Envelop shall be marked as "Financial Proposal" and "Technical Proposal" in bold and legible letter to avoid confusion. The financial and technical bids each consisting of the documents listed above.

In Technical Proposal the bidder must provide the original Data sheet and Income Tax, Sales Tax, dealership certificate and other documents, otherwise the bid will be ignored.

In Financial Proposal, the bidder should provide bid security / earnest money at the rate of 2% of the quoted value. A photocopy of the same should be attached with Technical proposal but its value must not be disclosed and this can be achieved by placing a piece of paper on the place where amount is mentioned.
- 6) All pages of the bid, except for un-amended printed literature, shall be initialed by the person or persons signing the bid.
- 7) The bid shall contain no alterations, omissions, or additions, unless corrections are initialed by the person or persons singe the bid.
- 8) Arithmetical error will be rectified on the following basis. If there is a discrepancy between the unit price and the total price, which is obtained by multiplying the unit price and quantity, or between subtotal and the total price, the unit or subtotal

price shall prevail, and the total price shall be corrected. If there is a dispensary between words and figures, the amount in words will prevail. If the Bidder does not accept the correction of errors, its bid will be rejected.

- 9) The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract under the relevant provisions of SPP Rules 2010, without thereby incurring any liability to the effected Bidders or any obligation to inform the effected Bidder or Bidders of the grounds for the Purchaser's action.
- 10) Prior to the expiration of the period of bid validity, the purchaser will notify the successful Bidder through Advance acceptance. This will constitute the formation of the contract. Within seven (07) days after receipt of the Advance acceptance, the successful Bidder shall furnish the performance security @ 5% of the contracted and will sign the contract agreement.
- 11) Distributor once nominated by the manufacturer will be for the whole contract period and manufacturer cannot change its distributor during the year in any case. In exceptional cases the tendering authority may be approve changes.

#### General & Special Conditions of Contract:-

- 1) The Contract shall be governed by and interpreted in accordance with law of the Islamic Republic of Pakistan.
- 2) Store is required immediately. The bidder may however give their short guaranteed delivery period by which the supply will be completed. No Extension will be granted / accorded for the supply.
- 3) Except as other wise, specifically provided in the contract, the Contractor shall bear and pay all taxes, duties, levies and charges assessed on the Contractor.
- 4) The Contract Price shall be made to the Contractor as specified in the Contract Agreement, subject to the general principal / procedure of the Government of Sindh.
- 5) The Contract shall be executed in accordance with the contract Documents and procedure.
- 6) The Contract warrants that the supplied equipment or any part thereof shall be free from defects in the design, engineering, materials etc. In care of defect in any part at the time of supply of installation it shall be replaced with new one instead of repair.
- 7) The purchaser, without prejudice to any other remedy for breach of contract by written notice of default sent to the supplier, may terminate this contract in whole or in part:
  - a) If the supplier fails to deliver any or all of the contracted items within the period (s) specified in the Contract, or within any extension thereof granted by the purchaser.
  - b) If the supplier fails to perform any other obligation (s) under the contract.
  - c) If the supplier, in the judgment of the Purchaser has engaged in corrupt or fraudulent practice in completing for or in executing the contract.

- 8) The bidder shall confirm the refund of cost difference if the same goods is/was supplied at lower rates to any other Govt./Semi Government institution or Armed Forces in the Province or outside in the same fiscal year.
- 9) The Purchaser reserves the right to increased/decrease or delete the quantities of goods etc. at the time of award of contract and also reserves the right to enhance the quantity by 15% of goods and services originally specified in the contract without any change in unit price or other terms and conditions of goods at any time during the contract period.
- 10) Stamp duty of 0.30% of the value of the Contract will be realized/charged by the A.G Sindh, while making payment to the contractors for award of each contract.





NOTE: - Eligibility of qualification for bid requires 65% or more score. If less then 03 bidders acquired the eligibility then the top three scoring bidders will be considered for financial competition.

The Financial bids of technically excepted bidders will be opened publically at a time announced by the procuring agency and the financial bids found technically non responsive shall be returned unopened to the respective bidders.

EVALUATION CRITERIA:-

For the purpose of determining the lowest evaluated bid, following facts other than price shall be taken into consideration by the Procurement Committee of this Hospital. The following merit point system for weighing evaluation factors/criteria can be applied for the TECHNICAL PROPOSALS. The number of points allocated to each factor shall be specified in the Evaluation Report.



After technical evaluation is completed, the Procuring Agency shall inform the bidders who have submitted proposals, the technical scores obtained by their technical proposal, and shall notify those bidders whose proposal did not meet the minimum qualifying marks which are 65% or were considered non-responsive, that their financial proposals shall be returned unopened after completing the selection process.
